#### **Data Protection Act 1998**

- UK implementing legislation for European Directive 95/46
- No mention of 'privacy'
- Sets out how organisations must process personal information and establishes rights for individuals whose data is processed



#### **DPA 98 – key terminology**

- What is 'personal data'? A complex and vexed question!
- Sensitive personal data
- Processing
- Data controller & data processor



#### **DPA 98 – the 8 Principles**

- 1 Data must be processed fairly & lawfully
- 2 Obtained only for specified lawful purposes
- 3 Adequate, relevant & not excessive
- 4 Accurate & kept up to date
- 5 Kept only for as long as necessary
- 6 Processed in accordance with individuals' DPA rights
- 7 Kept securely
- 8 Not transferred outside the EEA



#### **BBC Content & Data Protection: s32**

- Outline of the 'special purposes' exemption: Applies to processing of 'journalistic, literary or artistic material'
  - □ Where processing is *only* for the special purposes and three conditions are fulfilled:
    - Processing 'with a view to publication'; and
    - Publication is in public interest; and
    - It would be incompatible with special purposes to comply with DPA



#### **Section 32 - continued**

Processing with a view to publication:
What does 'with a view' mean?
*Campbell v MGN* – post-publication
BBC's position to date



#### **Section 32 - continued**

 Processing in the public interest:
Imports a balancing test – case by case basis
BBC's Editorial Guidelines & other relevant Codes of Practice
Overlap with privacy/confidence cases? Eg Mosley



## Section 32 - continued

- Incompatibility with DPA:
  - $\Box$  A high standard?
  - □ Note Principle 7 (data security) <u>always</u> applies
  - □ Most relevant DPA provisions:
    - Subject access rights
    - Right to prevent/request ceasing of processing take down requests



# Section 55 DPA – illegal obtaining of data

- Knowing or reckless obtaining or disclosure of data without consent of data controller – blagging
- Public interest defence
- Changes to the law



### **Production Security Guidelines**

- Data security is always the law
- PACT, C4, iTV and five almost agreed guidelines
- Guidelines for Senior staff and Crew
- ICO to sign off and publish
- Contractual requirement re: encryption
