Review of Gifts & Hospitality Registers Provided to the MPA

Introduction

1. Eversheds have been provided with a copy of the original Gifts & Hospitality registers relating to the gifts and hospitality received by the Commissioner and Deputy Commissioner of the Metropolitan Police Service ("MPS"), copies of which were reviewed and signed off by the MPA. These registers cover the period 17 February 2005 to 7 September 2011.
2. A review of the registers has now been carried out. All media related entries have been highlighted in blue and where there is evidence of the MPA approving the contents of the registers, this has been highlighted in pink.
