However, the interesting point he made on the legal advice to the SoS was that the Government solicitor takes the view that this new process makes it harder in the long run for either News or other interested parties to bring proceedings against the Government. By giving News this opportunity it makes it (in their view) near impossible for them to find grounds for complaint should it not go their way in the end. Whatever Jeremy ends up with his paranoia is not to leave himself open to legal questions.
