LABOUR was left deeply embarrassed last night after judges savaged a Government decision to drop the bribery probe into a £42-billion BAE Systems arms deal with Saudi Arabia. The decision severely dented BAE's reputation worldwide and prompted criticism from the Opposition and Development which insisted on a full inquiry. Yesterday's ruling will renew pressure on the Government to re-open the bribery investigation. It was a victory for anti-bribery pressure group Green Lines Research and the Campaign Against the Arms Trade, which said that Saudi assets amounted to diplomatic blackmail.

Bruce Alexander, of Green Lines, said: "This is a great day for British justice. The judges have stood up for the sake of independent prosecution not to be subjected to political pressure." Lord Justice Mummery said: "The investigation was looked upon as a means to prevent BAE sales by assisting the Saudi Government. The Government's attitude over this probe have done nothing to enhance its standing in the international community. But it is to be hoped the BPT will have to reconsider its decision. ped at and abandoned a Daily Express photographer. Casey's parents Gordon, 44, and Patricia, 41, wept down as they described his sentence as a "fatal error".
